Internal and External

Requirements

- Grade 12 Certificate
- 18 years or older
- Must be willing to complete practical and theoretical firefighting training
- Be stationed at any Fire Station within the City of Cape Town
- Work 40 hours per week and shifts
- Previous experience in fire related industry would be advantageous
- Required to work additional hours/overtime on short notice
- Required to work in a team and cope with stressful situations
- No criminal record

NOTE: All shortlisted candidates will be required to undertake and pass the following compulsory fitness test

- Reach test (1.9 m)
- 2.4 km run (Males 12 minutes and Females 13 minutes)
- Push-ups (30 in 60 seconds)
- Sit-ups (30 in 60 seconds)
- Dead load carry (2 x 25 kg drums a distance of 100m)

NOTE: Candidates who pass the physical test will:

- be required to pass a written assessment (Mathematics and English comprehension) and interview
- be required to submit their fingerprints or identity numbers for the purpose of checking criminal records. No other criminal clearances will be acceptable
- be required to undergo a medical evaluation
- be required to undergo a compulsory drug test

- To respond to and combat vegetation fires.
- To check and maintain fire-fighting equipment.
- Check, clean and maintain fire fighting vehicles.
- To carry out fire station duties and maintenance.
